**OBJECTIVE 1.1** The City of Portland EOC will activate on Tuesday, October 29<sup>th</sup> and Wednesday, October 30<sup>th</sup> starting 96 hours after and in response to a 9.0 Cascadia Subduction Zone Earthquake in accordance our processes, procedures, and plans including the ICS planning P to institute an emergency declaration, produce IAPs and situation status reports, process resource requests, and support peripheral Bureau and Team exercises that will occur simultaneously.

**OBJECTIVE 1.2** Portland Permitting and Development will coordinate with the City EOC to deploy safety inspection teams and share reports relating to critical infrastructure / buildings in response to a 9.0 Cascadia Subduction Zone Earthquake.

**OBJECTIVE 1.3** The Portland Bureau of Transportation will coordinate with the City EOC as they, among other BICP objectives, collect and communicate damage assessment information to the City of Portland EOC from their Bureau Incident Command Post in response to a 9.0 Cascadia Subduction Zone Earthquake.

**OBJECTIVE 1.4** Portland Neighborhood Emergency Team (NET) volunteers will deploy Tuesday, Oct 28<sup>th</sup> to participate in a drill where they use the NET DAMM ArcGIS Survey 123 tool to submit damage assessment data to the City of Portland EOC.

**OBJECTIVE 1.5** Neighborhood Emergency Team members will deploy

- Tuesday morning, Oct 28<sup>th</sup> to participate in a drill where they will submit damage assessment data using the DAMM tool, and
- Wednesday, Oct 30 from 1800-2100 for a Citywide Deployment Exercise to conduct local response to the 9.0 Cascadia Subduction Zone Earthquake according to their NET Team Operations Plans and the NET Guidebook.
